## Technical Industries Job Description

### NDT Superintendent

- To operate the UT and EMI units and to train safely all UT and EMI inspector trainees.
- To maintain all UT and EMI units and make sure they are calibrated, clean, painted, and in good working order at all times. **No equipment parts may be taken out without being immediately replaced.**
- To keep track of all transducers check each one properly and document each one. Be sure to keep all documentation on file.
- Make sure all inspection reports and paper work are filled-out correctly. Make sure strip charts and calibration charts for each pipe are documented.
- Assist in writing and improving S.O.P and Quality Manual.
- Check for safety hazards daily, report any hazards found to the safety supervisor and to your supervisor.
- Hold reasonable safety meeting with your crew.
- Make sure 3<sup>rd</sup> party personnel and outside contractors working in the yard follows the safety rules and the company policy hand book.
- Add more transducers to the UT head.
- Place a maintenance checklist on the wall in each unit.
- Report any problems with the UT or EMI units to your supervisor.
- To perform jobs given to him by his superior safely.

### Qualifications:

- High School Diploma or GED or higher education.
- Must read and write English.
- Must have a minimum of 3 years experience NDT technical and safe operation.
- Must have ASNT certified minimum level 2 in UT, MT, Dye Penetrant, MPI & EMI.
- Must have supervision experience and familiar with Safety, Technical and ISO procedures.
- Must clear back ground check and pass physical examination.
- Must present valid drivers licenses.
